7 New Business

7.1 Equipment Software Change Management

7.1.1 Background

7.1.1.1 In the semiconductor manufacturing process line, H/W and S/W updates to the equipment are performed but most cases are done manually under the customer's approval.

7.1.1.2 Such manual management can cause the inefficiency of version management between the equipment. It increases the possibility of human error and eventually lowers equipment availability, which can reduce equipment operation efficiency as a whole factory.

7.1.2 Discussion

7.1.2.1 Per the discussion, the committee decided to form a new task force to handle this activity.

7.1.2.2 Developing a new standard that only covers software version management is suitable rather than revising existing standards.

7.1.2.3 New activity only covers equipment software only. Application Level will not be included in the scope.

7.1.2.4 Version naming could be different from company to company.

7.1.2.5 Object Model for software version including sub-module version/hierarchy.

7.1.2.6 Committee agreed that there are many topics to discuss more for drafting scope and object. The discussion will be continued at the next meeting.
