Takehito Mizuno, co-leader, reported that the ballot review for #5421 was made at the section 6 above and the document failed and returned to rework.

And also Takehito Mizuno "There used to be a concern that Doc. 5188 by the North America Liquid Chemicals Committee and Doc. 5421 and Doc. 5297 by the Japan Liquid Chemicals Committee would be double standards. As a result of discussions between the two committees, SEMI presented a viewpoint in 2012 that those documents would not be double standards by deciding Doc. 5188 should be "Guide" and Doc. 5297 should be "Test Method" based on the SEMI Standards Regulations. The author of Doc. 5188 showed the same concern again through SEMI NA Staff in 2013, so that the SEMI Japan reported to SEMI North America that the both committees reached the agreement and the issue was already settled in the previous year. Japan Liquid Filter task force decided to send the ballot draft of Doc. 5421 to the members concerned in North America before the submission."
